COUNCIL ADOPTION OF THE 2011-2012 UNIFIED PLANNING WORK PROGRAM**

**WHEREAS**, the New York Metropolitan Transportation Council (NYMTC) is a regional council of governments which is the metropolitan planning organization for New York City, Long Island and the lower Hudson Valley; and

**WHEREAS**, pursuant to Federal planning regulations, NYMTC is responsible for the development of an annual Unified Planning Work Program (UPWP) which identifies the planning projects to be undertaken by its staff and the staffs of its member agencies; and

**WHEREAS**, the draft UPWP for the program year April 1, 2011 through March 31, 2012 identifies planning projects proposed for Federal and other funding; and

**WHEREAS**, NYMTC staff has determined that sufficient funds will be available to undertake the planning projects specified in the 2011-2012 UPWP during the program year; and

**WHEREAS**, NYMTC's Program, Finance, and Administration Committee, at its February 17, 2011 meeting, had recommended that this 2011-2012 UPWP be adopted by the Council.

**NOW, THEREFORE BE IT RESOLVED**, that the Council adopts the 2011-2012 Unified Planning Work Program.

This resolution shall take effect on the tenth day of March, two thousand and eleven.

**RESOLUTION #2011-2: AMENDMENT TO THE 2010-2035 REGIONAL TRANSPORTATION PLAN TO REVISE THE LIST OF STRATEGIC REGIONAL TRANSPORTATION INVESTMENTS OF THE SHARED REGIONAL VISION**

**WHEREAS**, the New York Metropolitan Transportation Council (NYMTC) is a regional council of governments which is the metropolitan planning organization for New York City, Long Island and the lower Hudson Valley; and

**WHEREAS**, pursuant to 23 U.S.C. 450.322, NYMTC is responsible for the development of a Regional Transportation Plan (RTP) for its planning area; and

**WHEREAS**, NYMTC's current 2010-2035 RTP, entitled *A Shared Vision for a Shared Future*, was adopted by the Council on September 24, 2009, having addressed all federal planning requirements set forth in 23 U.S.C. 450.322; and

**WHEREAS**, through ongoing planning in accordance with federal guidance, regulations and processes, NYMTC's Council members have identified revisions to the Strategic Regional Transportation Investments identified in the Plan as part of their Shared Vision for improving the transportation system in NYMTC's planning area; and

**WHEREAS**, as presented in Attachment 1, the revisions are to the vision element of the Plan and do not impact the fiscally-constrained list of projects/proposals/studies and maps contained in Appendices 1 and 2 of the Plan.

**NOW, THEREFORE BE IT RESOLVED**, that the Council adopts the attached revisions to the 2010-2035 Regional Transportation Plan.
