SYNOPSIS OF THE FEBRUARY 19, 2009 MEETING OF THE PROGRAM, FINANCE AND ADMINISTRATION COMMITTEE

A. CALL TO ORDER AND INTRODUCTIONS AND REPORTS

The meeting was called to order by Heather Sporn of the New York State Department of Transportation. Ms. Sporn welcomed the guest and said that she was representing the chair of the Program, Finance, and Administration Committee. The members introduced themselves and it was established that there was a quorum.

Ms. Sporn said that a special PFAC meeting would take place on March 5, 2009 in order to take critical and time sensitive action related to both the American Recovery and Reinvestment Act of 2009 and to the NYMTC's on-going planning process. She said as an approach to the economic recovery legislation, NYMTC had worked with their members and interested local parties to take the necessary planning and procedural steps to ensure the maximum flexibility in the use of economic recovery funds and to ensure that the region uses all of the funding that it possible can under the legislation.

B. PUBLIC PARTICIPATION

There were none registered to speak.

C. ACTION ITEMS

1. ACCEPT: JANUARY 15, 2009 MEETING SYNOPSIS

A motion to accept the January 15, 2009 Meeting Synopsis was made by Mr. Jack Schmidt, representing the New York City Transportation Coordinating Committee, and seconded by Mr. Robert Shinnick representing the Nassau/Suffolk Transportation Coordinating Committee. The meeting synopsis was unanimously accepted.

2. ADOPT: RESOLUTION #268 – ADOPTION OF PROJECTS INTO THE 2005-2030 REGIONAL TRANSPORTATION

Mr. Gerry Bogacz, NYMTC's Planning Group Director, said that the resolution included projects that could potentially be funded through the economic recovery legislation and that do not currently exists within the Regional Transportation Plan (RTP). He said requesting these projects into the fiscally constrained RTP would provide a basis for them in both the RTP and the Transportation Improvement Program should they be funded through the economic recovery legislation. Mr. Bogacz said that the included tables from the integrated financial assessment consisted of estimate figures of what the region may receive under the economic recovery legislation for a completely balanced picture for fiscal constraint.

A motion to adopt Resolution #268, Adoption of Projects into the 2005-2030 Regional Transportation Plan was made by Mr. Lawrence Berger, representing the Nassau/Suffolk Transportation Coordinating Committee, and seconded by Mr. John Pilner, representing the Mid-Hudson South Transportation Coordinating Committee. The resolution unanimously passed.

3. ADOPT: RESOLUTION #269 – ADOPTION OF THE CONSENSUS 2035 POPULATION AND EMPLOYMENT FORECASTS

Mr. Kuo-Chiao, NYMTC'S Technical Group Director, said that the Forecast Working Group had been working on the new forecast 2035 as required by the Regional Transportation Plan of the major investment studies. Mr. Chiao said that the resolution requests PFAC adoption of the 2035 Forecasts with the suggestion that the Forecast Working Group would meet 3-6 months to monitor the economic change and take appropriate action.

A motion to adopt Resolution #269, Adoption of the Consensus 2035 Population and Employment Forecasts was made by Mr. Jack Schmidt, representing the New York City Transportation Coordinating Committee, and seconded by Mr. Patrick Gerdin, representing the Mid-Hudson South Transportation Coordinating Committee. The resolution unanimously passed.

D. CONFIRMATION OF SPECIAL PFAC MEETING

A special PFAC meeting was confirmed to be held on Thursday, March 5, 2009 at 1:15 p.m. at the NYMTC Office.

E. CONFIRMATION OF ANNUAL COUNCIL MEETING

The Annual Council Meeting was confirmed to be held on Thursday, March 19, 2009 at 10 a.m. at New York University.
